- FIREARMS OR OTHER WEAPONS ARE NOT ALLOWED
- KEEP BALLFIELD GATES CLOSED
- NO BIKES ON BALLFIELD
- NO DOGS ON BALLFIELD 🐕
- NO FIRES; NO ILLEGAL FIREWORKS
- NO GLASS CONTAINERS
- NO LITTERING OR DUMPING OF TRASH!!! USE TRASH CONTAINERS PLEASE!!!
- NO LOUD MUSIC
- NO OVERNIGHT CAMPING
- NO PARKING OR DRIVING ON GRASS
- NO RECREATIONAL VEHICLES ALLOWED ANYWHERE THROUGHOUT PARK
- NO VANDALISM OR DEFACING OF CITY PROPERTY
- PARENTS ARE RESPONSIBLE FOR MINOR CHILDREN
- PET OWNERS ARE RESPONSIBLE FOR ANY INJURIES OR DAMAGE CAUSED BY THEIR PETS; OWNERS SHOULD NOT LEAVE PETS UNATTENDED AT ANY TIME; VISITING PETS SHOULD WEAR A COLLAR AND ID TAGS AT ALL TIMES
- THE CITY OF PLEASANT VALLEY RESERVES THE RIGHT TO CLOSE THIS FACILITY TO CERTAIN ACTIVITIES, DURING CERTAIN PERIODS, AND/OR TO CERTAIN INDIVIDUAL PEOPLE OR PERSONS OR PATRON GROUPS AT ANY TIME
